Collaborative Provision Strategy Group

Review and approve collaborative provision

Roles and Responsibilities

Senior Pro Vice Chancellor

Leads on external relations, recruitment, employability, registry and planning. Chairs Learning & Teaching Committee and the Collaborative Provision Strategy Group.

PVC for Learning, Teaching and Innovation

Responsible for the quality and standard of academic programmes, the development and enhancement of the student experience, learning and teaching research and widening participation
(NB responsibilities currently transferred to Senior PVC while postholder is on secondment)

PVC for Business Partnerships and Knowledge Transfer

Facilitates links with business, responsible for commercialisation strategy, etc, Chairs Community and Business Engagement Committee

PVC for Research

Chairs Research Committee. Responsible for REF submission, strategy, grant income, etc.

Chief Operating Officer (University Secretary-Registrar)

responsible for the welfare of staff and students, through the direct leadership of Human Resources, Staff Development, Equality & Diversity, Student Support, Residences, Sport and Recreation, Health & Safety, the Nursery, Security, Campus Services, Chaplaincy, the Library, and the primary liaison between the University and the Students' Guild.

Head of Curriculum Learner and Development

Head of CLIPP (Centre for Learning Innovation and Professional Practice); chairs Programme Approval Sub Committee.

School Level (ABS, EAS, LHS, LSS)

Learning and Teaching Committee

Module and course approval, annual monitoring periodic review, development of School Learning and Teaching Strategy

School Boards

Approval of credit rated short courses (role currently under review); Annual module and course review; reports to LTC

Module and Exam Boards

Responsible for quality and consistency in assessment

Roles and Responsibilities
